### Part A: Pupil premium strategy plan

#### Statement of intent

Ultimately, we aspire that every child identified as being disadvantaged, make equal or better progress then other pupils, whatever the subject. We intend that they are equipped with the tools, confidence and knowledge to continue to succeed in the next stage of their educational journey.

To achieve this for our disadvantaged learners, we aspire to provide them with the richest, broadest educational experiences, allowing them to develop their own Cultural Capital in line with other pupils. We intend to support this through ensuring that they receive whatever targeted adult support, intervention or teaching is required to achieve our aims.

#### **Challenges**

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

	Detail of challenge
1	Gaps in learning are apparent across the curriculum and across the year groups, undoubtedly impacted by previous lockdowns and the weaknesses in core skills and languages, identified in Reception. This means that some pupils, and especially those with SEND, need to make sustained accelerated progress to achieve ARE.
2	Lack of cultural capital and wider experiences amongst some of those disadvantaged learners. Limited experience of Diversity and different social contexts has led to limited ambition.
3	Mental health and self-esteem
4	Poor language development and exposure amongst some disadvantaged learners which impacts upon their ability to read and write.
	Poor phonic knowledge and use

Effective feedback tends to focus on the task, subject and self-regulation strategies: it provides specific information on how to improve.</li> <li>Feedback can be effective during, immediately after and some time after learning. Feedback policies should not over specify the frequency of feedback</li> <li>Feedback can come from a variety of sources — studies have shown positive effects of feedback from teachers and peers. Feedback delivered by digital technology also has positive effects (albeit slightly lower than the overall average).</li> <li>Different methods of feedback delivery can be effective and feedback should not be limited exclusively to written marking. Studies of verbal feedback show slightly higher impacts overall (+7 months). Written marking may play one part of an effective feedback strategy – but it is crucial to monitor impacts on staff workload.</li> <li>It is important to give feedback when things are correct — not just when they are incorrect. Approaches that either deliver instruction through teaching assistants or in small groups rather than one to one have smaller positive effects, on average, but may be a cost-effective solution to providing targeted support. 4. For one to one tuition led by teaching assistants, interventions are likely to be particularly beneficial when the teaching assistants are experienced, well-trained and supported – for example, delivering a structured intervention. How effective is the approach? Evidence indicates that one to one tuition can be effective, providing approximately five additional months' progress on average. Short, regular sessions (about 30 minutes, three to five times a week) over a set period of time (up to ten weeks) appear to result in optimum impact. Evidence also suggests tuition should be additional to, but explicitly linked with, normal teaching, and that teachers should monitor progress to ensure the tutoring is beneficial. Studies comparing one to one with small group tuition show mixed results. In some cases one to one tuition has led to greater improvement, while in others tuition in groups of two or three has been equally or even more effective. The variability in findings may suggest it is the particular type or quality of teaching enabled by very small groups that is important, rather than the precise size of the group. Programmes involving teaching assistants or volunteers can have a valuable impact, but may be less effective than those using experienced and specifically trained teachers. Where tuition is delivered by volunteers or teaching assistants there is

evidence that training and the use of a structured programme is advisable.
